

Muslim Demands For Women

For many weeks and months I have been writing and speaking about the impending dangers that radical Islamic followers pose to the American way of life. Not necessarily dangerous in a military sense, although that will always be a threat, but rather a much more subtle attack from the inside on our culture and traditions. The more dangerous attacks will come through our court systems and liberal judges will be the willing accomplices before, during and after the fact by convincing the media and other gullible minds that the changes in American ways to accommodate the Muslim culture are necessary to allow the assimilation of our two ways of life. The only problem will be that the Americans will be assimilating into the minority Muslim culture rather than the other way around.

Radical Muslim males are too cunning to make a frontal assault on our system so they will do as their counterparts hiding underground in Iraq are doing... sending their wives and children out in front of them to say and do what they demand. We all know, from actual statements of Muslim women and the Muslim Holy Quran itself, that wives and daughters of Islam hold no position of authority in the family and would not even venture out of the house without their husband's or Imam's permission. Consequently, anything said or attempted by Muslim females will be strict obedience to orders from above.

Many Americans are unaware of what is already transpiring throughout the United States and, therefore, no outrage is being raised. One of my goals with this column is to make you aware so you may recognize the first volleys of Islamic cannons aimed at your gut. Here are a few examples of what is already happening while you sleep.

- In North Seattle, Washington, a public pool has restricted times when non-Muslims may use the pool so that Muslim women and daughters may swim unobserved. Men, even if they are lifeguards, are banned from the pool for that time.**
- In Lincoln Park, Michigan, a local physical fitness facility, Fitness USA caved in under pressure when Muslim women demanded that the gym accommodate them by walling off a room where co-ed aerobics are held from the women-only section so men couldn't see them while exercising.**
- In Bridgeview, Illinois, a Muslim school is seeking non-Muslim public schools to play their women's basketball team on road games. One catch... the public schools would have to ban men and teenage boys from the audience.**

- **In Omaha, Nebraska, the city just settled a suit filed by the American Civil Liberties Union (ACLU) on behalf of Lubna Hussein. They filed the suit when the city refused Ms. Hussein entry to the public pool because she and her daughters would not adhere to proper dress codes required at the public pool. The city had to change their dress code to accommodate Ms. Hussein's religious belief.**

In all of the examples listed above, the businesses and public facilities were asked to “accommodate followers of one interpretation of Islamic law that says the sexes must be separate if women are not covered with headscarves and modest clothing.

What do some Islamic scholars say about the incidents listed, plus others around the nation? Zuhdi Jasser, chairman of American Islamic Forum for Democracy, which advocates separation of religion and government, commented thusly, “In the long term it does not serve to build friends and bridges with the Western community. “You’re not going to make your American, Christian and Jewish friends to feel comfortable... which in the end could create a dislike for Muslims that is unnatural.”

However, other Muslims are crying foul and saying that Muslim women have a Civil Rights violation and the director of Muslim Public Affairs Council has said they have a right given to them by the first Amendment to ask for special accommodations based on religious beliefs. Oh, if the same could apply to our Christian citizens.

A professor of Middle East studies at Florida Atlantic University sees it differently. He feels as I do, that these demands being put forth by Muslim women are only a precursor of greater demands to come in the future as Muslims ratchet up their pressure in a worldwide Islamic movement to coerce Western governments into abiding by Islamic laws.

Professor Walid Phares continued by saying, “These demands exist because there is an ideology of a militant movement to slowly but surely demand more... they will be building on it.” He also says, “the ultra-conservative Islamic sect, known as Wahhabism, trying to assert itself as representing all Muslims in the USA and makes demands most Muslims disagree with.”

On the other side of the coin, Ebrahim Moosa, professor of Islamic studies at Duke University says the requests are “attempts to integrate with U.S. culture. They show that America can become their home.” Folks are we really suppose to believe that rhetoric?

Well, regardless of the way you lean on this issue... you’ve been notified in advance as to what is happening... I suggest you think and pray on it and continue to watch future events with a greater knowledge of what’s going on. As the old adage says, “Forewarned is forearmed.”
